

TOWN OF PERU SELECT BOARD MEETING MINUTES, MAY 13, 2024

Patrick motioned, Jason seconded, to approve minutes of May 6, 2024. All in favor.

ELECTED AND APPOINTED OFFICIALS/COMMITTEE REPORTS:

- Road commissioner Brad Hutchings prepped Brown Hill Road for a skim coat of paving, using FEMA money from the December 23 storm.
- He will pave 210 feet of Dolloff Street; skim coat will be applied on corner of Dolloff Street and North Main Street.
- May 2024 FEMA claim is 75% complete.
- Contents of the Conex box at the temporary shelter are partially moved. No electrical is moved yet.
- In response to Karen Lark, Brad stated that Sicotte Road is 16.5-foot wide; Old Valley Road is a four-rod county road. Karen said Old Valley Road is ditched to a certain point; needs a ditch to contain the water after that.
- Fire chief, town clerk/treasurer were not present.

UNFINISHED BUSINESS:

- Katie motioned, Jason seconded, to accept CWT's bid for the new town garage for \$446,000.00, with a completion date of October 31, 2024. All in favor. Patrick offered to contact Clifton Thurston to tell him. Phelan Construction bid \$736,000.00.
- Jason motioned, Pat seconded, to table the time clock discussion. All in favor.
- Greg Freeman and Neil Sorensen accepted the 2024 Spirit of American award.
- Lyndzi Dolloff will hang the swings this week.
- Gail motioned, Jason seconded, to table secretary vacancy discussion. All in favor.
- The board will try to work on the draft solar ordinance at the May 20 board meeting.

NEW BUSINESS:

- Dave Douglass of As Remembered, LLC, will be in Peru on May 15, 2024, to tour DeShon Cemetery regarding resuming cleaning veterans' headstones.

- Jackie Child declined to present her requested address to the board.
- Katie motioned, Gail seconded, to move the review of warrants #23, payroll and accounts payable, to the end of the regular agenda. All in favor.

ROUNDTABLE/REMINDERS:

- Cemeteries walk-around tentative date for June 22. More discussion next meeting.
- Bruce Cox plans to present an ATV club municipal grant application to the board for review and signatures.
- A letter regarding a Gammon Road junk yard was forwarded to the CEO.
- Katie shared that she has organized a group of people to work at the town ball field's infield over Memorial Day weekend.
- Katie will contact Cliff Thurston regarding updated bids for plumbing and electricity for the new town garage. It's believed the bids we have now may have been updated.
- The board's consensus is not to contact the town's insurance company regarding bonding for candidates for public office.
- Pat motioned, Jason seconded, to accept accounts payable warrant #23 for \$242,837.55. All in favor.
- Pat motioned, Gail seconded, to accept payroll warrant #23 for \$14,043.82. The vote was 3-1, Katie opposed.

PUBLIC PARTICIPATION:

- Gail motioned, Jason seconded, to enter public participation at 6:58 p.m.
- Raquel asked for a re-reading of the vote on the market adjustment at the May 6, 2024, meeting. Raquel asked how many accounts for the new town garage – should have had two general ledgers and offset accounts.
- Jane Newton asked how to access board meeting minutes, since they aren't posted on the town web site currently. She can get copies at the town office or have them e-mailed to her.
- Karen Lark asked if the town still has an ordinance committee: no, it has been four or five years without one. The select board would have to write ordinances, if needed. She asked if the trailer with a very littered yard on Route 108 has been contacted. CEO is aware of the situation.
- Lynda: will \$264,000 and a loan of up to \$400,000 be enough to build the garage?
- Donna Brackett asked if the public could see the town garage ledgers.
- Louanne and Mike Thibodeau discussed having a town-wide informational meeting regarding market adjustment. Lynda agrees that the board should have been more forthcoming with information about it.
- There was other general discussion regarding market adjustment and revaluation.
- Gail motioned, Jason seconded, to exit public participation at 7:35 p.m. All in favor.
